10-Year EXTENDED Warranty

Coverages

The Gutter Geeks, LLC warrants to the homeowner(s)/building owners located at the address and on the date specified herein that the metal used on seamless aluminum gutters (only) by The Gutter Geeks, LLC will not peel, chip, crack, split, flake or blister under conditions of normal wear for a period of ten (10) years from the date of installation. Should the materials fail to perform in accordance with the above standards, and under proper notification and inspection by The Gutter Geeks, LLC, The Gutter Geeks, LLC shall at its sole option either repair, replace, refinish or refund any defective materials.

Sealed seams at end caps and miters are guaranteed not to leak for a period of ten (10) years

Workmanship is guaranteed for a period of (10) years. This ensures that the system was originally installed according to industry standards and that no initial install mistakes were made.

The Gutter Geeks, LLC will assume one hundred (100%) percent of the material cost for validated claims made during the first three (3) years after installation. Beginning on the fourth year of the warranty period, The Gutter Geeks, LLC's share of such costs will be reduced to ninety (90%) percent. Each year thereafter through the tenth (10) year The Gutter Geeks, LLC's share will cumulatively decrease from ninety (90%) percent by five (5%) percent increments per year.
